I provide domestic help in 5 - 6 house holds at Dharampur. On 15.05.2022, while I was going towards the house of Mr. Gupta for doing my job. His house is uphill side. He restrained my way towards his house and said to me that "तू बड़ी हीरोइन बनती है". He further said that " तू बड़ी हीरोइन बनती है तू मेरे साथ धंधा कर मैं तेरी सारी गरीबी दूर कर दूंगा". Four days earlier when I went to his house and while I was brooming his room, his son Subhagya came there and said to me that there is no need to broom the room and you better broom the outside portion. Then Subhagya said that your services are no more required on which I said that my due payment be made and then I will stop the work. Gupta also said to me on that day i.e., 15.05.2022 that "तू चमारी बड़ी हीरोइन बनती है" | He also groped my breasts on that day. There, I narrated the incident to Mr. Sethi. Then I disclosed the matter to Jaspreet who is member of Panchayat and son of Sethi. He assured me to confront the accused. I also disclosed this fact to the Ward Member Nirmla Devi. I have given seven days time to the accused to settle the matter but they did not turn up but instead they defamed me in the public and intimidated me to do away with my life. On the eighth day I went to the police and gave my report Ex.P-9/PW5. I disclosed to the police that place where the incident had happened. Police prepared the map of it. Police also photographed that place. The photographs are Ex.P-10/PW5 and Ex.P-11/PW5. I got my statement recorded in a Court at Kasauli which is Ex.P-12/PW5. Accused Subhagya is present in the Court. However, his father Gupta is not present. I can identify him as well.

This incident happened at 12:36 PM. This area is papulous. Had I cried at that time people may have come, however, I did not make any cry. I mentioned this fact in my statement to the police that accused threatened to kill me. I had also told to the police that I had given seven days time to the accused for settling the matter. Witness confronted with statement Mark D-1 wherein it is not so recorded. It is incorrect that I disclosed to Jaspreet only this fact that my salary is due towards the accused and you please help me to get it released. It is correct that Jaspreet assured me that he will get my salary released from them. It is incorrect that I have foisted this false case against the accused on a dispute regarding payment of salary. It is incorrect that nothing as alleged has ever happened. It is incorrect that I am deposing falsely.
