Further Cross-examination by Sri. GKPJ Advocate for Accused:-

5. My father and mother came out of the house after 5 minutes of accused ran away from the spot. Then Keshav, Umesh and Gangadhar came. Motorcycle was parked upwards of our house. Motorcycle was parked in a distance of around 20-30 feet from our house.

6. Split-up accused Aziz came to our house around 9.00 p.m. He alone came. When he came we were standing near motorcycle. 10-15 our villagers gathered at that time.

7. Immediately after scream from my sister, we ran towards bathroom. It is false to suggest that by the time we reached bathroom, accused had already left the spot. It is false to suggest that we did not see accused at the spot and he was not peeping.

8. After 2 days police came to our house. On the same day of incident also, the police came and enquired me. The

police enquired me, my sister and others. The police were present for about One hour. I, my sister, my cousin brother, my father, my mother and others were present when police came. Since 25 years, we have been staying in the house. Stone was kept adjacent to wall. Our house is surrounded with forest. It is true after sunset, surrounding our house is covered with dark. Adjacent to bathroom there is light. Except that there are no lights surrounding our house.

9. The distance between our house and Konaje Police Station is morethan 1km. Since it was night, on that day we did not go to police station, on the next day morning we went to police station and lodged complaint. Surrounding bathroom is vacant place. Two stones were kept adjacent to bathroom wall. My cousin brother Hemanth wrote complaint in police station. I was present when complaint was written. It is false to suggest that my brother wrote complaint as per the say of police. I have read complaint before making signature in the police station. I and my brother went to police station first, then Gangadhar, Umesh and Keshav came. We went to police station at 1.00 p.m. We were in police station for One hour. I studied upto 7th standard. I know reading and writing Kannada.

10. It is false to suggest that the accused had no knowledge that we belong to S.C. prior to the incident. The

distance between our house and house of accused is around half kilometer. It is false to suggest that prior to incident, the accused had no knowledge that we belongs to S.C.

11. The police took motorcycle on the same day of incident. On the road infront of our house, the accused and his family members move.

12. We got compensation from Government in this case. To get compensation, Keshav, Gangadhar and Umesh assisted us.

13. Since our house is surrounded by forest area, porcupine and other wild animals used to come near our house.

14. After 2 days, the police came to our house in the evening. Two police came. At that time I, my sister, my brother, my mother were present. Apart from us no body was present. Police wrote on the spot. The police did not type anything in computer. I have signed on Ex.P2 in house. I have read contents of mahazar. It is false to suggest that I have signed mahazar in police station. It is false to suggest that police did not come to our house and did not conduct mahazar.

15. It is false to suggest that no such incident as stated

by me in chief examination took place. It is false to suggest that since our house is surrounded with forest, when some animal came near our house, we thought somebody came to our house and lodged false complaint against accused. It is false to suggest that since motorcycle of accused was parked on account of repair, hence we thought the accused came to our house and we lodged false complaint. It is false to suggest that the accused has no nexus to the case.

16. The houses of Ismail and Sharif are nearby our house. There are several houses nearby our houses. They are Hameed, Sharif, Ismail, Gangadhar, Umesh, Keshav, Shekar, Narayan and Ravi etc,. After the incident all the aforesaid persons came to spot.

17. When Aziz came to take motorcycle, the villagers enquired him.
