ORDER

1. Second bail application filed under Section 439 Cr.P.C. for the grant of bail to the applicant in case FIR No.40, dated 25-03-2019, under Section 21/22/29-61-85 of the Narcotic Drugs and Psychotropic Substances Act, 1985, (for short the 'Act') registered at Police Station City, Gurdaspur.
2. Notice of the bail application was issued to the respondent-State and the police record received and perused.

3. Learned counsel for applicant moved this second bail application for adding Section 29 of the N.D.P.S. Act. It is averred in the application that in the present case, this court granted regular bail vide order dated 18-04-2019, but later-on it transpired that Section 29 of N.D.P.S Act has been added later-on by the police. Hence, this second bail application and prayed that in this view of the matter, present application be allowed and Section 29 of N.D.P.S. Act may be added in the interest of justice.

4. Perusal of the record shows that this Court granted the regular bail vide order dated 18-04-2019 but the police later-on added Section 29 of N.D.P.S. Act. Without expressing anything on the merit of the case, the instant application for adding Section 29 of N.D.P.S. Act is hereby allowed , subject to furnishing of bail bonds and surety bonds in the sum of Rs.50,000/- with one surety of the like amount before Trial Court/ Duty Judge. Police record returned. Papers be tagged with the remand papers.
