J U D G E M E N T

(Delivered on this the 30th day of January of the year 2023)

1. This judgment shall dispose of the above mentioned Regular Inventory Proceedings, which was filed upon the death of Mr. Alvaro De Sousa Bras Gomes alias Alvaro De Sousa Braz Gomes and his wife, Mrs. Maria De Gloria Braz Gomes.

2. This Inventory was filed under section 373(1)(b) of the Goa Succession, Special Notaries and Inventory Proceedings Act, 2012, seeking a declaration in respect of the heirs of the Estate Leaver

couple. This Inventory Proceeding was initiated by the son of the Estate Leaver couple.

3. Vide Order dated 20.01.2023, the Applicant was appointed as the Head of the Family. The Head of the Family appeared (through his Attorney) and was then administered the oath of office. He then filed his Declaration on Oath, wherein he set out that the Estate Leaver couple both passed away intestate. He further set out that the estate leaver couple left behind two children – an unmarried daughter and a married son, as their sole and universal heirs. The names and details of the three Interested Parties are set out in the Declaration on Oath.

4. The Interested Parties are duly represented in this Inventory by the same Advocate. The Interested Parties have not contested the version set out by the Head of the Family.

5. By this Order, it is hereby declared that the Head of the Family, namely Mr. Francisco Antonio de Jesus Pereira Braz Gomes (who is

married to Mrs. Belinda Theresa Braz Gomes alias Belinda Theresa M.D Souza alias Belinda Anthony Braz Gomes) and Miss. Maria Virginia de Santa Rita Filomena Pereira Bras Gomes alias Maria Virginia Bras Gomes are the sole and universal heirs of the Estate Leaver couple named above.
