Cross Examination by Sri. VRGP For R2:-

I had DL at the time of accident. Witness has produced the DL. The accident spot was a slight curve road. I saw the rikshaw before the accident about 15 feet away. There were not other vehicles motor cycle and autorikshaw. The accident occurred on the tar road. The width of the road was 16 feet. My motor cycle was 4 feet away from the left side of the road. There was the mud road beside the tar road on the left side. The headlight of autorikshaw and my my motorcycle was on.

2. My wife gave complaint about the accident. It is false to suggest that the accident occurred due to my negligence and rashness. It is false to suggest that the autorikshaw was moving very slow. It is false to suggest that we have filed

false case against driver only to get compensation. I have not filed any other compensation case before any other case. It is false to suggest that I have not suffered any injuries in the accident. It is false to suggest that I was not an inpatient for 4 times in Tejaswini Hospital nor did I spend 20 lakhs for medical expenses. Dr.Shantarama shetty and Mahabalashetty and Dr. Ajith treated me. Dr.Deepak Rai treated me in Yenapoya Hospital when there was malunion of fracture. It is false to suggest that treatment taken in Yenapoya is not related to the injuries suffered in the accident.

3. Dhanaraj Shetty and Preeti G shetty were attending me at the hospital. It is false to suggest there were no attendants to take care of me and I have not paid any salary to them. I went for follow up treatment 3 times to Deepak Rai. I have produced prescriptions. It is false to suggest that I have not taken any follow up treatment.

4. I got Disability certificate from Dr. Shantaram Shetty. I have informed him about my treatment with Dr. Deepak Rai. Dr. Shantaram Sheety did not ask about my job at the time of disability examination and they have suggested not to work. I have certificate about it. Deepak Rai gave the estimation for removal of implants. Dr. Deepak Rai advised for removal of implants. It is false to suggest that I am falsely deposing that there is further expenses for removal of implants. It is false to suggest that by using my influence I got disability certificate.

It is false to suggest that I have not suffered any disability as mentioned in the petition.

5. After the accident I have not filed IT returns due to loss of my business. I have accounts in Indian Bank in Bombay and Canara Bank, Kinnigoli. I was running the Hotel in Surathkal and Bombay. It is false to suggest that the both hotels are still running. I had license in the name owner by name Soumya Kumar in Suratkal and in my name in Bombay. She is the owner of the building. It is false to suggest that I did not have any hotel business and in collusion with Soumya Kumar created Ex.P11. It is false to suggest that for the same reason I have not produced the documents related to my bank account. It is false to suggest that the documents of IT returns are created by showing higher income. It is false to suggest that I did not have the avocation and the income as stated in the petition. It is false to suggest that I have not suffered any loss of income due to the injuries in the accident. It is false to suggest that only to get compensation falsely deposing before the court. I can produce the statement relating to my bank accounts.
