ORDER

1. This order of mine shall decide this application for pre-arrest bail U/s.438 of CrPC filed in the above noted FIR on behalf of applicant, on the ground that he is innocent and has been falsely implicated in this case. The application filed CRM-M No.40648 of 2021 for quashing of present FIR as compromise between the parties has been effected. Nothing is to be recovered from the applicant and he is ready to join investigation. Hence, it is prayed that the application be allowed and applicant be given the concession of pre-arrest bail.

2. Notice of bail application was issued to State and Sh.Jagjit Singh Addl.Public Prosecutor put in appearance on behalf of State. Record has also been requisitioned.

3. I have heard arguments of counsel for applicant and learned Addl.Public Prosecutor for State and have gone through the record.

4. This is the second bail application as first bail application was dismissed as withdrawn on 14.09.2021. Now, second bail application has been filed on the basis of changed circumstances as matter has been compromised between the parties and parties have filed petition U/s.482 CrPC in Hon'ble High Court, which is registered as CRM-M-40648 of 2021 and Hon'ble High Court vide order dated 29.09.2021 has directed the trial court/Ilqa Magistrate to record statement with regard to compromise/settlement within 30 days from that day.

5. So, in order to facilitate the applicant to appear before the trial court/Duty Magistrate, the applicant is directed to join the investigation and would come present as and when called for by the police and in the event of his arrest, the applicant shall be admitted to interim bail on his furnishing personal and surety bonds to the satisfaction of Arresting/Investigating Officer. The applicant shall also abide by the conditions as specified under Section 438(2) of CrPC. Let record be now produced on 12.10.2021.
