ORDER

File put up before me being Duty Officer as learned Presiding Officer is availing summer vacations. Vide this order, I intend to dispose of bail application under Section 438 Cr.P.C filed by applicant-accused in the FIR mentioned above.

Police file received and perused.

Learned counsel for accused/applicant has argued that accused/applicant has been falsely implicated in the case in hand. Since, the accused/applicant has already joined the investigation, as such, her custodial interrogation is not required and accordingly bail application be allowed.

Learned Addl.PP for State argued that present case is registered

on the basis of true facts.

I have considered the submissions of learned counsel for the applicant/accused and learned Addl.PP for State.

ASI Jaspal Singh has made a statement that accused/applicant has joined the investigation as per the order of the Hon'ble Court dated 30.05.2023, and her custodial interrogation is not required. The accused/applicant is also not required for further investigation. No bail application of the accused/applicant is pending before the Hon'ble High Court.

In terms of order dated 30.05.2023 passed by the court of Sh.Vikrant Kumar, learned Additional Sessions Judge, Moga, the accused/applicant has already joined the investigation and as per statement of investigating officer, her custodial interrogation is not required. The culpability of applicant-accused shall be gauged during the course of trial. So, without much commenting upon merits of the case, the present bail application is allowed and the order dated 30.05.2023 is made absolute. File be sent back to the concerned court for consignment purpose.
