O R D E R

1. Applicant, Gursewak Singh @ Sewak son of S.Mehar Singh, has filed this bail application under section 438 Cr.P.C. as he was apprehending his arrest in case having FIR No.8 dated 12.01.2017 under

section 61/1/14 of Punjab Excise Act, 1914, Police Station Gharinda.

2. On notice, Additional Public Prosecutor opposed the bail application.

3. I have heard counsel for the applicant/accused and the Additional Public Prosecutor for the State and have gone through the record.

4. The applicant jumped bail in the trial court on 01.10.2018 and consequently, non-bailable warrants of arrest were issued against him. In the meantime the present bail application has been moved by the applicant.

5. The applicant has already joined the proceedings in the trial court on the basis of order of interim bail passed by this court on 18.10.2018. To this effect, report has been received from the trial court. So, no purpose will be served by sending the applicant in custody at this stage.

6. In the light of above discussion, this bail application is allowed and order of interim bail dated 18.10.2018 is hereby made absolute. The applicant should appear in the trial court on each and every date of hearing. However, the trial court is at liberty to proceed against the applicant/accused under section 446 Cr.P.C. Copy of this order be sent

to the trial court and file of this bail application be consigned to the record room.
