Judgement

1. As Per The Case Of The Prosecution, The Offence Punishable U/S. 65AA Of The Gujarat Prohibition Act, 1949 Is **Made Out** Against The Accused.
2. On Submission Of Police Report Under Section 173(2) Of Cr.P.C., The Copy Of The Police Report And Other Documents Were Furnished To The Accused Person(S) Under Section 207 Of Cr.P.C. Thereafter, The Substance Of The Accusation Was Stated To The Accused Person(S) And Asked Whether He Pleads Guilty Or Has Defence To Make. Thereon, The Accused Pleaded Guilty To The Charge And Submitted A Purnis In This Regard.
3. The Accused Pleaded That It Is Voluntary Admission Of Guilt And It Is The First Such Offence Committed By The Accused. The Commission Of The Offence Is Repented By The Accused And Pleaded For Mercy.
4. Looking To The Facts Of The Present Case, Circumstances Of The Accused And Voluntary Admission Of Guilt On The Part Of The Accused, The Following Order Is Passed In The Interest Of Justice.

Order

The Accused Is Convicted U/S. 252 Of Cr.P.C. Of The Offence Punishable Under Section 65AA Of The Gujarat Prohibition Act, 1949 And Is Sentenced To Undergo Trc And Pay Fine Of Rs. 100/- (Rupees One Hundred Only). In Default Of Payment Of Fine, To Undergo Simple Imprisonment For 10 (Ten) Days.
