shall pay fine of Rs. 500 /- and Rs. 2500 /- for the

Bharatiya Nyaya Sanhita, 2023 respectively, will meet the ends of
justice. Hence, I pass following order:-

ORDER

1) Accused Sadik Ali Sabit Ali Shaikh
is convicted vide section 275 of the Bharatiya Nagarik Suraksha
Sanhita, 2023 and he shall pay fine of Rs. 500 /-
(Rs. Five hundred only) for the commission of
offence punishable U/Sec. 287 of the Bharatiya Nyaya Sanhita, 2023
and Rs. 2500 /- (Rs. Two thousand Five hundred only) for
the commission of offence punishable U/Sec. 125 of the Bharatiya
Nyaya Sanhita, 2023, i.e. total fine of Rs. 3000 /-
(Rs. Three thousand only) and in default of payment he
shall suffer simple imprisonment for a period of five (5) days.

2) Copy of this order be given to the accused free of costs.
