O R D E R

1. This application for pre-arrest bail has been filed by
applicant/accused, Manjinder Kumar son of Lachhman Dass, in complaint
titled “Dharamvir Singh Versus Manjinder Kumar” under section 138 of
Negotiable Instrument Act as he jumped bail in the trial court on

25.09.2018 and his non-bailable warrants of arrest were issued.

2. Upon notice, respondent/complainant appeared through counsel and contested the bail application.

3. Vide order dated 18.10.2018 applicant was directed to appear in the trial court/duty magistrate within next seven days and on his appearance he was directed to be released on interim bail by the said court to its own satisfaction.

4. During the pendency of this bail application, applicant made payment of Rs.30,000/- to the respondent/complainant. The applicant was directed to appear in the trial court and on his appearance he was directed to be released on interim bail by the said court to its own satisfaction. However, the applicant failed to comply with the said order despite availing 2-3 opportunities. So, this court is of the view that applicant is not entitled to get concession of anticipatory bail.

5. Accordingly, this bail application is hereby dismissed. The order of interim bail dated 18.10.2018 passed by this court stands vacated. File be consigned to the record room.
