Sri.A.K.S, Advocate filed Vakalath for accused No.3 and also filed application U/s.205 of Cr.P.C. and same is hereby allowed. Appearance of the accused No.3 is hereby dispensed with a day.

Sri.P.S.L, Advocate filed Vakalath for accused No.2 and Sri.S.S.D, Advocate filed Vakalath for accused No.4 and they also filed bail applications U/s.436 of Cr.P.C seeking to enlarge them on bail for the alleged offences punishable under Sec.13(1) Karnataka Agricultural Pests and Diseases Act.

Since the alleged offences are bailable in nature, accused No.2 and 4 are enlarged on bail for following conditions:

1. The accused No.2 and 4 persons shall execute personal bond for sum of Rs.50,000/- each.
2. The accused No.2 and 4 shall not tamper the prosecution evidence and shall not threaten the prosecution witnesses in any manner.
3. The accused No.2 and 4 shall not commit the similar offences again.
4. The accused No.2 and 4 shall co-operate with the investigation officer for investigation.

5. The accused No.2 and 4 shall appear before this court on all dates of hearing without fail.

Surety by name Sri.Roshan Crasta, S/o Thomas Crasta, Aged about 48 years, R/at Door No.7-63/21, Saripalla, Alape, S.B.Nagara, Mangaluru, D.K.District, is present before the court and offered his surety-ship to the accused No.2 and offered his surety property bearing Sy.No.63/3A1P16 measuring an extent of 0.12.00 acres situated at Alape Village, Mangaluru Taluk. The market value of the property is Rs.20,00,000/-. Perused the document and he has also produced RTC extract and copy of his Aadhar Card.

Another surety by name Sri.Naveen Prashanth D'Souza, S/o late Lawrence D'Souza, Aged about 50 years, R/at Door No.2-12-945/23, Flat No.504, Highgroove Apartment, Bejai Church Road, Bijai, Mangaluru Taluk, is present before the court and offered his surety-ship to the accused No.4 and offered his surety property bearing Revenue Sy.No.41 (Khatha No.3161) measuring an extent of 0.35.00 and 0.06.00 acres situated at Mangaluru City Corporation. The market value of the property is Rs.10,00,000/-.

Perused the document and he has also produced Khatha extract and copy of his Aadhar Card.

Enquired the sureties. Their surety-ships are satisfied and accepted.

Office is directed to take necessary Bail Bonds from the accused No.2 and 4 and sureties.
