CHARGE

I, Smt. Kumari Sujatha, B.Com., LL.B., III Addl. Sr. Civil Judge
and J.M.F.C, Hubli do hereby charge you accused :

1. Mohammadgouse S/o Rehmansab Kalasapur of
Dharwad.
2. Noorahmed S/o Rehamansab Kalasapur
of Dharwad.
3. Smt. Shamshad Begum W/o Abdulsab Dharwadkar
R/o : Dharwad.

as under :

That, CW-8 Mohammad Kasim and CW-17 Gulshadbegum since
from 8 months were friends on facebook and the same matter came to
the knowledge of you A-1 and A-2 i.e., brothers of CW-17 and in that
connection you warned CW.8 to leave the friendship with
Gulshadbegum but, they continued the friendship and in that grudge,
on 18-08-2018 at about 13.55 hours you A-1 and 2 being the brothers
and A-3 being the sister of Gulshadbegum R/o Dharwad in furtherance
of your common intention to commit an offence came near the

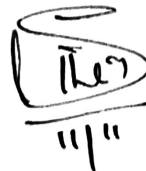


Volkswagen car showroom, and entered into the cabin of complainant wherein CW-8 was working and picked up quarrel with him and voluntarily caused simple hurt to the CW-8 with your hands and thereby committed an offence punishable U/Sec. 323 R/w Sec. 34 of IPC and within my cognizance.

Secondly, that you all the above named accused on the aforesaid date, time and place in furtherance of your common intention to commit an offence kidnapped CW-8 and took him in Ford Figo Car No. KA-37 M-7522 to the road leading towards Daneshwari nagar, Vidyagiri, Dharwad and thereby you have committed an offence punishable under Sec. 363 R/w Sec. 34 of IPC and within my cognizance.

Thirdly that you all the above named accused on the aforesaid date, time and place in furtherance of your common intention to commit an offence, abused CW-8 as "ಬೋಸಡಿ ಮಗನೆ, ಸೂಳೆ ಮಗನೆ " and intentionally insulted him by abusing him in filthy language, and thereby gave him undue provocation, intending that such provocation would cause him to commit breach of public peace and thereby committed an offence punishable U/Sec. 504 r/w. 149 IPC and within my cognizance.

Lastly, that you all above named accused on the above said date, time and place in furtherance of your common intention to commit an offence, committed criminal intimidation to CW-8 by threatening that "ಇನ್ನೊಮ್ಮೆ ಗುಲಶಾದಬೆಗಂಳಿಗೆ ಸಂಪರ್ಕಿಸಿದರೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ", with an

intention to cause them alarm and thereby committed an offence punishable U/Sec. 506 r/w. 149 IPC and within my cognizance.

And I do hereby direct that you be tried by me on the aforesaid charges.
