ORDER

The petition filed by the petitioner U/Sec. 166 of M.V. Act claiming the compensation is hereby allowed in part with costs.

The petitioner is entitled to the compensation of Rs.14,34,510/- with future interest at the rate of 6% p.a., from the date of petition till its realization.

The respondents are directed to deposit the award amount before this Tribunal within 3 months.

On deposit being made 40% of the amount awarded to the share of petitioner is ordered to be released in her favour and remaining 60% is ordered to be deposited in fixed deposit in the name of petitioner in

**any nationalized bank of her choice
for the period of 3 years.**
