

Order passed below application Exh.9 of accused No.2-Akshay
Tupe for grant of bail under Section 483 of B.N.S.S. 2023
(Passed on this 31st March, 2025)

1. Vide the present application under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023, the accused No.2-Akshay Suresh Tupe sought for regular bail in Crime No.347/2025 registered with Police Station Hadapsar, Pune, for the offences punishable under Sections 74 & 118(1) r/w. 3(5) of Bharatiya Nyaya Sanhita, 2023 and Sections 8 & 12 of Protection of Children from Sexual Offences Act, 2012.

2. Perused the application, say of A.P.P. on it on the same application and investigation papers in charge-sheet.

3. Heard, Learned Adv. Mr. P. P. Patil for the accused No.2, Ld. Adv. Mr. S. D. Pansare for informant and Learned A.P. P. Mrs. V. H. Jadhav for the State.

4. Brief facts of the prosecution case is as under,

That alleged incident took place on 14.3.2025 at about 5.00 p.m. at Magarpatta, Hadapsar, Pune. On the day of incident, informant, girls and their friend were present in a function organised on spot on account of Holy Festival. At that time, accused No.1 caught hold the informant, tried to kiss her and she pushed him. Informant's friend had opposed the accused No.1, who got annoyed, he abused & beaten the informant's friend. Accused No.2 came there and he started to abuse & beat the

informant's friend with belt and he badly touched the girls with informant and outraged the modesty of informant & girls.

5. Ld. A. P .P. & Ld. Advocate for informant have opposed the application for bail.

6. Investigating officer has completed the investigation and filed the charge-sheet against them. Accused Nos.1 & 2 are present before the Court. As the investigating officer has filed the charge-sheet against the accused Nos.1 & 2, it transpires that investigating officer did not require the physical custody of them. Hence, accused No.2 is entitled to be released on bail. In result, application is liable to be allowed subject to conditions and I proceed to pass the following order.

ORDER

1. Application vide Exh.9 of accused No.2 for grant of regular bail, is hereby allowed.
2. Accused No.2- Akshay SureshTupe, R/o. Malwadi, Hadapsar, Pune, be released on execution of P. R. Bond of Rs.25,000/- and Surety Bond of like amount with one or two sureties subject to conditions.
 - i) Accused No.2 shall not threaten or pressurize of the informant, victim girls & witnesses and he shall not tamper the evidence.
 - ii) Accused No.2 shall remain present on due dates of this case.
