It is ordered and awarded that:

ORDER

The petition filed by the petitioner U/Sec.166 of M.V. Act claiming compensation is hereby partly allowed with costs.

The petitioner is entitled to the compensation of Rs.48,307/- with interest at the rate of 6% p.a., from the date of petition till its realization.

The respondent No.2 company is directed to deposit the compensation amount within three months from the date of this order.

The respondent No.2 is at liberty to recover the same from respondent No.1 as per law.

Since the award amount is meager one, on deposit being made, entire amount is ordered to be released infavour of the petitioner.

Advocate fee is fixed at Rs.500/-.
