It is hereby ordered and decreed that:

The suit of the Plaintiff is partly decreed with costs.

It is hereby declared that the correct name of the Plaintiff's minor son is "Istharthayya".

Defendant No.3/Registrar of Births and Deaths, HDMC, Hubballi (or the competent authority concerned), is hereby directed, by way of mandatory injunction, to correct the entry relating to the name of the Plaintiff's minor son in the Birth Register and to issue a fresh Birth Certificate incorporating the child's correct name as "Istharthayya", in accordance with the provisions of the Registration of Births and Deaths Act, 1969, the Rules framed thereunder, and other applicable statutory provisions.

It is made clear that this decree is confined only to the correction of the name of the minor child in the birth records and shall not be construed as declaring or altering any other particulars recorded therein.
