It is hereby ordered and decreed that:

The suit of the Plaintiff is hereby decreed with costs.

It is hereby declared that the correct name of the Plaintiff is "Yogesh Pomappa Lamani".

Consequently, the defendants are directed, by way of mandatory injunction, to effect necessary corrections in the educational and other public records maintained by them pertaining to the Plaintiff by retaining the existing entry and incorporating the declared name as an alias, so that the Plaintiff's name shall be reflected as:

"Yogesh S/o Pumappa Lamani @ Yogesh Pomappa Lamani"

or in such other equivalent manner as may be administratively feasible, clearly indicating that "Yogesh Pomappa Lamani" is the correct and declared name of the Plaintiff, while preserving continuity of the existing records.

The aforesaid corrections shall be carried out within sixty (60) days from the date of receipt of a certified copy of this Judgement and Decree, after due verification of the identity of the Plaintiff.
