B.A. M.B.A LL.B., Civil Judge & J.M.F.C Court., Kalaghatagi, in the presence of Sri. V.H. Kulkarni Advocate for Plaintiff, Sri. R.S. Hosamath Advocate for Defendant No.1 and 2.

It is hereby ordered and Decreed

The suit filed by the plaintiff is hereby partly decreed with costs in the following terms:

The defendants are hereby directed to pay to the Plaintiff a sum of Rupees Rs.93,338/- (Rupees Ninety-Three Thousand Three Hundred and Thirty-Eight only) towards the principal amount.

The Plaintiff is entitled to pre-suit interest at the rate of 6% per annum on the principal sum of Rupees Rs.93,338/- from 17.03.2020 till 20.09.2022, amounting to Rupees Rs.14,070/-.

The Plaintiff is further entitled to pendente lite interest at the rate of 6% per annum on the principal sum of Rs.93,338/- from 20.09.2022 till the date of decree.

The Plaintiff is also entitled to future interest at the rate of 6% per annum on the principal sum of Rs.93,338/- from the date of decree till realization of the entire decretal amount, in terms of Section 34 of the Code of Civil Procedure, 1908.

It is clarified that interest shall be computed only on the principal sum of Rs.93,338/- and not on the accrued interest.

The claim of the Plaintiff for interest at the rate of 18% per annum is hereby rejected for want of proof of any contractual stipulation or other legally sustainable basis for such rate.
