Cross Examination by : Sri.VHK (Learned counsel for defendants)

1. I had joined as PDO, Sangameshwar in the year August 2022. I have been in service since 20 years. I have been serving as PDO since 16 years. I had served in Harobelavadige village, Dharwad Taluka prior to my service at Sangameshwar.

2. The Grampanchayath president or the PDO of Grampanchayath would place orders for procuring materials for Grampanchayath purposes. The same is followed in all Grampanchayaths across this place.

3. I know the Grampanchayath president of Sangameshwar Grampanchayath who had served on 17.03.2020. Her name is Dilashadbi Yallappur.

4. I now see documents shown to me already marked as Ex.P.1. The said documents is on a letter head of the Grampanchayath (Defendant No.1). The said document is an indent issued by the president of c. I was not severing at Grampanchayath Sangameshwar on the date specified in Ex.P.1. I identify the signature of the president, Grampanchayath Sangameshwar affixed on Ex.P.1. The same is herewith marked as Ex.P1(a). The witness voluntary states that there are two errors on Ex.P.1 they are “2019-2020” on date specified in the document. The same is herewith marked as Ex.P.1(b). The second error is the date specified on the document “17.04.2020”. It is true to suggest that, the said date ought to have been mentioned as “17.03.2020”. The same is herewith marked as Ex.P.1(c). The said indent in Ex.P.1 was actually issued on 17.03.2020.

5. It is false to suggest that, in case of urgency, either the PDO or Grampanchayath president would procure materials. Piped water supplied is provided for the inhabitants of Grampanchayath Sangameshwar. There are borewells installed for the said water supply. The said borewells have been installed prior to my joining at Grampanchayath Sangameshwar as PDO. For the said water supply, it requires motor pump of 4HP and 10HP capacity.

6. I now see a document shown to me which is already marked as Ex.P.2. The materials specified in Ex.P.2 and in Ex.P.1 are the same. Any staff of Grampanchayath Sangameshwar will receive the materials by affixing their signature on the invoice. The same is made on Ex.P.2

as well. I am unable to say the name of the staff member of Grampanchayath Sangameshwar who had received the materials specified in Ex.P.2.

7. I now see a document shown to me which is already marked as Ex.P.3. The said letter was addressed by the plaintiff to defendant No.2.

Further cross examination of DW1 is deferred.
