Cross examination by : Learned AGP (proposed defendant No.2).

1. I have given instructions to my advocate for filing this suit. I have sought relief of changing the surname of my mother from Hunasimarad to Bhovi in Panchayath records of my property. The correct name of my mother is Shantavva Bhovi. The complete name of my father is Mallangappa Bhovi.

2. I am the only daughter of my parents Shantavva and Mallangappa Bhovi. I now see a document shown to me which is already marked as Ex.P.1. The said document is Hakku Patra. The name mentioned in the said document is Mahadevappa H Hunasinamarada. The said person is not related to me. The other name mentioned in the said document is Shantavva Mahadevappa Hunasinamarada. The said person is not related to me. My name, address and other particulars mentioned in the cause title of the plaint in this suit is correct. I am the resident of Basaveshwar nagara, Kalaghatagi. There is a link between myself and bhovi oni. My house is situated at Bhovi oni. My mother had lived in the property

mentioned in Ex.P-1 during her life time. My mother had died in the same property mentioned in Ex.P-1.

3. I now see a document shown to me which is already marked as Ex.P.2. The address mentioned in Ex.P-2 as Bhovi oni is falsely mentioned. It is false to suggest that, the said death certificate marked as Ex.P-2 is a false certificate. The contents of Ex.P-2 are true and correct. The name of mother of Shantavva mentioned in Ex.P-2 as Pakiravva Navalagund is correct. The name of the husband of Shantavva mentioned in Ex.P-2 as Mallangappa Bhovi is correct. The place of death of Shantavva as Bhovi oni, Kalaghatagi mentioned in Ex.P-2 is correct. I do not know in who's name the house located at Bhovi oni is in existence.

4. The house located in Bhovi oni is in the name of one Shantavva. I am only legal heir of said Shantavva and there are no other persons as legal heir for her. It is true to suggest that, the house belonging to Shantavva devolves upon me after her death. When there is already a house property in the name of my mother no plot will be allotted under Government Ashraya Yogana Scheme. No plot has been allotted in the name of mother by the Panchayath. The name mentioned as Shantavva Mahadevappa Hunasinamarada is nowhere related to the name of my mother Shantavva. I have not produced the application filed by my mother in the Panchayath for the allotment of plot under the Government Ashraya Yogana Scheme, in the file of this Court in this case. I have not produced the plot allotment resolution passed by Panchayath, in the file of this Court. I have not produced the extract of register maintained by the Panchayath, in the file of Court in this case. I have not sought for relief of correction of my mother's name in the said register of allotment of plots maintained by Panchayath, in this case.

5. I now see a document shown to me which is already marked as Ex.P.3. The person by name Laxmi W/o. Hanumanthappa mentioned in the said document is my younger sister. The said Laxmi is not a party in this suit. I had no impediment to make Laxmi as a party to this suit. Since I am illiterate I do not know in which year the plot was allotted to my mother as per Ex.P-1. It is true to suggest that, the plot was allotted to my mother in year 1997-98.

6. My mother had demised in the year 2008 as per Ex.P-2. My mother had neither applied before any authority or before any Court seeking to change her husband's name or her surname. I do not know the boundaries of the plot allotted to my mother. It is false to suggest that, I have filed this suit with an intention to grab the property allotted to one Shantavva W/o. Mahadevappa Hunasinamarada as per Ex.P-1. The witness voluntarily states that, she admits that she had not impleaded her brother and sisters. My brother's name is Hanamappa Bhovi S/o. Mallangappa Bhovi. My brother is correctly residing at Guruvinahalli. It is true to suggest that, Ex.P-3 was obtained by me by giving false information to Tahasildar. It is false to suggest that, I have filed this case and produced false documents to make entries in the Panchayath records in my name.
