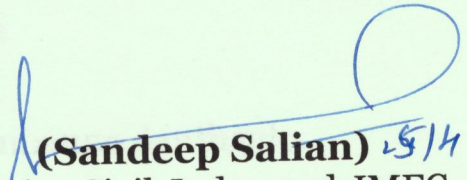
11. Whether the defendant No.5 to 7 and 11 to 14 proves that the Sy.No. 1544 is the self acquired property of Basappa ?
