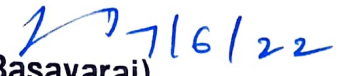
Charge

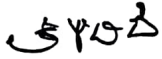

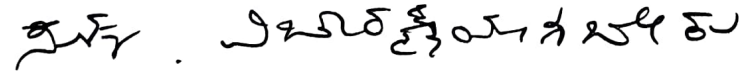

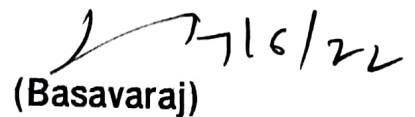
