This is an application u/s-439 of Cr.P.C. moved by the Ld. Advocate for the accused-petitioner namely, **Mamin Sarkar @ Abdul Mamin Sarkar** praying bail.

Both Case Diary and Original Case Record are received.

It is stated in the petition that no other bail petition is filed or pending before the Appellate Authorities of this Court.

Ld. Advocate for the accused-petitioner has prayed for releasing the accused on bail on the ground that the accused person has been falsely implicated in this case and there is no chance of his absconding.

Ld. P.P raised objection against such submission and has prayed for rejection of bail.

I have heard the submissions made by the Ld. Adv. for the accused-petitioner as well as the Ld. P.P for the prosecution through V.C.

C.D produced.

On meticulous perusal of the CD along with statement of the witnesses u/s-161 CrPC and the statement of the victim, so recorded under section 164 of the Cr.P.C. I find that there are sufficient materials against the present accused-petitioner regarding his involvement in the commission of crime.

Thus, considering the materials available in the CD and LCR as well as the nature and gravity of the offence, I do not propose to release the accused-petitioner on bail.

Accordingly the prayer for bail stands rejected.
