COPY OF ORDER DTD. 20.08.2026

The record is put up again for hearing of bail application of the petitioner Ananda Kumar Padhi @ Padhy as per Section 483 B.N.S.S. TCR is received from the trial Court. One certificate is given to the bail application that no other bail application is filed or pending before any higher forum. Heard both the sides i.e. the ld. counsel for the petitioner as well as the Addl.P.P.

2. The learned counsel for the accused persons/petitioner submitted that the petitioner surrendered before the Court of learned J.M.F.C., Jajpur Road as per the direction of the Hon'ble Court in ABLAPL No. 8984 of 2026. The said Court rejected the bail application in the first hour and as such the petitioner has come to this forum in the second hour as per the direction of Hon'ble Court. It was submitted that up to date C.D has been submitted by the I.O. Co-accused person is on bail.

The learned Addl.P.P raised objection to the bail application on the ground that the accused person has absconded after the crime.

3. Perused the order of the Hon'ble High Court, Orissa. The relevant portion of the order dated 22.07.2026 in ABLAPL No. 8984 of 2026 as follows:

“ In the event of his surrender and motion for bail, the same be considered by the learned J.M.F.C, Jajpur Road on merits, in the first hour of the day.

In the event of rejection of the prayer for bail by the learned J.M.F.C, Jajpur Road, Jajpur, the petitioner is at liberty to move the higher forum for bail in the second hour on the same day.

6. *On being so moved, the higher forum is requested to make an endeavor to dispose of the bail application of the petitioner on the same day.*

The case diary shall be made available to the concerned courts to facilitate disposal of the bail application of the Petitioner and learned J.M.F.C, Jajpur Road, Jajpur is called upon to transmit the case record to the higher forum in the second hour expeditiously in the event of rejection of such bail application by him.

Ground of parity, if any, may be considered by the learned court (s) below. The forums below are requested to verify the criminal antecedents of the Petitioner of similar nature.

10. *Accordingly, the ABLAPL stands disposed of.”*

4. Perused the case record, it reveals that the co-accused person has already been released on bail and the petitioner has one criminal antecedent but the trial has not completed. The accused person is taken into judicial custody on 20.08.2026.

5. With due regard to the order of the Hon'ble High Court, keeping in view of the grounds of parity, let the accused person/petitioner namely Ananda Kumar Padhi @ Padhy, aged about 28 years, S/o- Manmath Padhi @ Padhy of Vill-Krushnanagar, P.S- Jajpur Road, Dist-Jajpur be released on bail on filing bail bonds to the tune of **Rs.50,000/-(Rupees fifty thousand)** with **two** solvent sureties each for the like amount to the satisfaction of the Court below with conditions that:

- i. The petitioner shall not commit any offence while on bail.
- ii. The petitioner shall appear before the learned Court below on each date, when the case would be posted.
- iii. The petitioner shall not directly or indirectly make any inducement, threat or promise to any other witnesses or tamper evidence of this case.
- iv. The petitioner shall make himself available for interrogation as and when required by the police officer.
- v. The petitioner will not leave India without the

previous permission of the Court.

Violation of any of the above conditions shall entail cancellation of the bail of the petitioner.

The bail application is disposed of accordingly. Send a copy of this order along with the TCR to learned J.M.F.C., Jajpur Road for information and necessary action.
