This is an application u/s-439 of Cr.P.C. moved by the Ld. Advocate for the accused-petitioner namely, **Amrit Chandra Roy @ Amrita Roy** praying bail.

Both Case Diary and Original Case Record are received.

It is stated in the petition that no other bail petition is filed or pending before the Appellate Authorities of this Court.

Ld. Advocate for the accused-petitioner has prayed for releasing the accused on bail on the ground that the accused person has been falsely implicated in this case and there is no chance of his absconding.

Ld. Advocate for the accused-petitioner further submits that the anticipatory bail under section 438 of the Code of Criminal Procedure of all other co-accused persons has been allowed by the Ld. Sessions Judge Dakshin Dinajpur at Balurghat.

On careful perusal of the record, I find that the present accused petitioner has been in custody since 17-10-2022. It further reveals from the record that the principal accused No. 1/ wife along with other accused persons have already been granted anticipatory bail in c/w Crl. Misc. No. 1158 of 2022 dated 03-11-2022, vide Order No. 2 by the Ld. Sessions Judge, Dakshin Dinajpur. Thus, having considering facts and circumstances as well as the period of detention suffered by the accused-petitioner, I am inclined to allow the prayer for bail of the accused-petitioner.

Accordingly, the accused-petitioner, namely, **Amrit Chandra Roy @ Amrita Roy**, may be released on bail. **He** may find bail bond of Rs. 5000/- with

two registered sureties each of Rs. 2500/- subject to the satisfaction of Ld. ACJM Gangarampur at Buniadpur.

The Ld. ACJM Gangarampur at Buniadpur, is hereby requested to release the accused-petitioner on furnishing bail bond.

Copy of this order be sent to the Ld. ACJM Gangarampur at Buniadpur for information.

Thus this Crl. Misc. Case being No. 199 of 2022, is disposed of.
