It is ordered and awarded that:

ORDER ON JOINT MEMO

The minor guardian of petitioner i.e., her natural mother present.

Both side counsel present. Both side parties settled their dispute amicably.

The respondent No.4 ready to pay the amount of Rs.20,000/- and respondent No.2 ready to pay amount

of Rs.25,000/- i.e., respondent No.2 and 4 are insurance company. The natural mother of petitioner totally from respondent No.2 and 4 ready to receive the amount of Rs.45,000/-.

Minor guardian of petitioner ready to accept the said amount as per joint memo.

After the deposit of the amount by the respondent No.2 and 4 the entire amount be release infavour of minor guardian of petitioner.

Hence the petition is allowed in part with cost as to the terms of the Joint memo.

JOINT MEMO

The petitioner having filed the claim petition claiming the compensation on account of the injuries/death, the petitioner and the Respondent Insurance company agreed to settle the claim in full and final settlement for **Rs.20,000/- (Rupees Twenty Thousand only)** prays to pass an award, accordingly. The Respondant agrees to deposit the said amount within 3 months failling which the said amount shall carry an interest at the rate of ... from the date of the decree. (The interest of the minor will be safe guarded by making necessary deposits as per the decree to be passed.) The petitioner is not entitled for any cost.
