Continued order no.17 dated 05.01.2023

Considering the factual aspect of the matter and materials in C.D. and also for the interest of further investigation, prayer for further remanding the Accused to J.C. is considered and allowed.

Another petition has been filed by the I.O. of this case through Ld. Special P.P. of NIA praying for passing order (a) to allow the prosecution/NIA to produce and file 13 original Seizure Lists dated 04.01.2023 and (b) to allow the prosecution/NIA to retain the Seized Articles dated 04.01.2023 in NIA Malkhana in the interest of further investigation.

Seen the 13 seizure lists dated 04.01.2023 and perused the petition and the material on record.

Heard Ld. Special P.P. of NIA.

Prayer for retention of Seized Articles in NIA Malkhana is considered and allowed in the interest of investigation.

Prosecution is permitted to retain the Seized Articles in NIA Malkhana as per Seizure Lists dated 04.01.2023.

One forwarding letter along with two medical reports in respect of the Accused nos.(A-11 and 17) has been received from the Superintendent of Presidency Correctional Home vide office letter no.135/IMB dated 04.01.2022 in terms of order no.13 dated 22.12.2022 passed by this Court.

Let those be kept in the record.

All the Accused persons except the Accused no.(A-13) who is on A.I. Bail are remanded to J.C. till 19.01.2023.

Fix **19.01.2023** for production of the accused persons, appearance of the accused no.(A-13), Md. Imran and hearing of Bail Application dated 23.12.2022 filed by Accused no.(A-25).

The accused no.(A-13), Md. Imran as before.
