So, they be summoned throughailable warrants in the sum of Rs.10000/- with one surety in the like amount each. Summons issued to PW Manish Kumar received back unserved. Summons issued to Pws ASI Pardeep Kumar, EASI Suresh Kumar not received back. Now to come up on 03.09.2026 for prosecution evidence. Fresh summons to Pws Manish, ASI Pardeep Kumar, EASI Suresh Kumar be issued for the date fixed.

The case falls under the category of Action Plan.

Till then, accused Bagicha Singh and Sandeep are remanded to judicial custody and be produced before the Court on the date fixed through video-conference, unless otherwise directed.

With a view to ensuring expeditious progress of the trial and strict compliance with judicial directions, the ACP, Headquarters, Panchkula is directed to personally supervise the execution of summons/process issued to the prosecution witnesses. The concerned SHO/Incharge, Summoning Staff shall ensure the presence of all prosecution witnesses on the next date of hearing, failing which the defaulting officer(s) shall remain personally present before this Court to explain the lapse.

A copy of this order be forwarded to the DCP, Panchkula for information, necessary compliance and to ensure accountability in the execution of Court process.
