Prosecution/NIA is directed to ensure the production of the case diary before this court on the next date fixed i.e 21.08.2023 positively.

No report is filed by the concerned I.O in respect of the petition dated 24.07.2023 filed by on behalf of the accused persons namely (A-2) Md. Sahabuddin Siddique and (A-8) Gholam Md. Izhar regarding returning personal belongings/articles in terms of the order no. 64 dated 24.07.2023.

I.O is further directed to submit the report regarding the same on the next date positively i.e on 21.08.2023.
