I.O. has submitted in his prayer that the cognizance of offence be taken against the Accused no.(A-12) as per the prayer made in the charge- sheet.

I.O. has also prayed for allowing the NIA to continue investigation of the case u/s 173(8) Cr. P.C. to unearth the larger conspiracy involved in the case and to identify the source of explosives and other associates involved in the crime under the purview of law.

Perused the case record and the documents relied upon by the prosecution including the charge-sheet.

It appears that prima facie Prosecution has been able to make out a case against the Accused no.(A-12).

Thus, cognizance of offence is TAKEN considering the materials on record.

Prayer of the I.O. regarding continuation of further investigation of the case u/s 173(8) Cr. P.C. is considered and allowed for the interest of investigation supplementing to it.
