2. Accused submitted that he is from poor family and he is sole bread earner of his family. he prayed for lesser punishment by showing his leniency.

3. Considering the nature of the offence following sentence appears to be just and sufficient. Hence the order.

Accused **Rahul Avinash Deshmukh** stands convicted under section 252(2) of Criminal Procedure Code, 1973 for the offence under section 283 of Indian Penal Code and is sentenced to pay fine of Rs.200/- (Rs. Two hundred only). he shall suffer in default sentence of simple imprisonment for one day.
