the claim petition.

**Cross-examination by Sri. ML Advocate for the respondent
No.2**

1) On the date of accident, I had been to my mother-in-law's
house in my bike. I have no DL to ride the Motorbike. I was
proceeding from Sundahalli village to Channarayapatna. It is
true to suggest that accident spot is situated on the Hirisave-
Shravanabelagola Main Road. It is false to suggest

that divider is present in the Hirisave-Shravanabelagola Main Road.

2) It is false to suggest that on the date of accident I myself ride the bike in rash and negligent manner and thrust to the Autorickshaw and caused the accident. It is false to suggest that I without holding DL to ride the bike negligently rode it and hence solely responsible for the accident.

3) After the accident, I was shifted to Shravanabelagola hospital. It is false to suggest that I was in a conscious state of mind at the time of shifting to Shravanabelagola hospital. I gained conscious in the Shravanabelagola hospital thereafter. I have not given information to the doctors about the mode and manner of the accident and details of the vehicle.

4) I have not taken any treatment at Shravanabelagola hospital. I was shifted to Punya hospital, Channarayapatna. Police have taken my statement at Punya hospital after two days from the accident. It is false to suggest that since accident taken place due to my fault, I have filed complaint belatedly after two days.

5) I had taken treatment at Punya hospital, Channarayapatna as inpatient for 10 days. I have not underwent any surgery. It is false to suggest that I have produced created medical bills in order to get compensation.

6) I had supplied milk to Govt., Dairy. It is true to suggest that now also I am supplying milk to dairy. RTC stands in the name of my mother. Now also I am cultivating the said land. It is false to suggest that there is no loss of income. It is false to suggest that since accident taken place due to my fault, the Insurance Company is not liable to pay the compensation.
