PETITION CLAIM:

This is a claim petition for grant of compensation of
Rs.20,00,000/- (Rs. Twenty Lakhs only) from the respondents

due to injuries sustained in road traffic accident that occurred on 08.02.2025 at 12.30 a.m on Hirisave village, Hirisave Hobli, Channaraypatna.

This petition coming on this 29th day of June 2026 for final disposal before Smt. Kalpana M.S., BSC, LLM , PGDCLCF., 4th Addl. District and Sessions Judge, Hassan (Sit at Channarayapatna) in the presence of Sri. AGD for the Petitioner and Sri.ML- Advocate for the Respondent No.2 and Respondent No.1 exparte.

It is ordered that petition filed under Section 166 of Motor Vehicle Act is allowed in part with cost.

It is further ordered that, claimant is entitled for compensation of Rs.1,90,000/- (One lakh ninety thousand) with interest at the rate of 6% P.A. from the date of petition till realization.

It is further ordered that, respondent No.2 shall deposit the compensation amount with interest, within 30 days from the date of award, failing, which the award amount shall carry interest at the rate of 9% per annum from the date of default.

It is further ordered that, on deposit, considering the quantum of compensation, the entire amount is ordered to be released in favour of claimant on proper identification. Advocate's fee is fixed at Rs.1,000/-.
