Examination in chief by way of Affidavit of Petitioner:

I have filed my affidavit in lieu of examination in chief. The contents of affidavit are true and correct. I have given instructions to prepare the affidavit. It bears my signature.

I have produced the documents and marked as under:

ExP13: The attested copy of MLC register extract

ExP14: Entire case sheet

ExP15: X-ray

Cross-examination by Sri. ML Advocate for Respondent No.2

:

1) I have examined the injured claimant when I was serving in the govt., hospital, Channarayapatna. The age of injury is within 6 to 12 hours. Injured informed that before visiting the Channarayapatna hospital, they have first aid treatment at govt hospital Hirisave, but not produced any

documents. It is true to suggest that the MLC intimation will be given by the hospital in which first aid treatment taken by the injured in RTA. I have not verified the MLC intimation given by Hirisave govt., hospital.

2) It is true to suggest that injured has taken the entire treatment in the govt hospital, Channarayapatna. On the same day, I have given MLC intimation. I have not enclosed police intimation copy. X-ray was taken on the same day. It is true to suggest that I have produced attested copies of the document. Original copies are stored in the hospital records by keeping the scanned copies.

3) It is true to suggest that ExP11 is issued by govt., hospital, Channarayapatna. It is true to suggest that in ExP11 it is mentioned that history of RTA is self fall. It is true to suggest that when the claimant visited the govt., hospital, Channarayapatna he was in conscious state. The information given by the injured was recorded by the duty doctor on the same day of visit. While issuing Discharge summary by oversight I have written as self fall. It is true to suggest that in

MLC register, it is mentioned regarding date, time and place of Road Traffic Accident, but details of the vehicle involved in the accident is not mentioned. It is true to suggest that I used to verify case sheet, MLC register extract and other documents before issuing Discharge summary. It is true to suggest that I have issued ExP11-Discharge summary after verification of the entire case file.

4) It is true to suggest that wound certificate is issued by the govt., hospital, Channarayapatna. It is true to suggest that in ExP8-wound certificate, it is mentioned that said document is issued by referring the Discharge summary given at Punya hospital. The said portion of the wound certificate is marked as **ExP8(a)**. It is true to suggest that claimant has not taken any treatment at Punya hospital, Channarayapatna. It is false to suggest that the claimant has suffered injuries in some other incident and taken treatment in the govt., hospital.

5) After surgery I have taken check X-ray. As per check X-ray the surgery is satisfactory. I cannot say the date of follow up treatment on OPD basis. I have prepared a clinical notes regarding that discomforts of claimant during recent

examination, but not produced the said notes before this court. It is true to suggest that as per the recent X-ray, the fractured bone is united, witness volunteers that the bone is malunited. It is false to suggest that I have assessed the disability by mentioning the exaggerated figures. It is true to suggest that the partial disability to the left lower limb will be decreased while calculating the disability.

6) It is true to suggest that in the govt hospital, future surgery will be conducted free of cost. It is true to suggest that surgery was conducted to the claimant free of cost in the govt., hospital. It is false to suggest that claimant has not suffered any disability and I am giving false evidence.
