PETITION CLAIM:

This is a claim petition for grant of compensation of Rs.60,00,000/- (Rs. Sixty Lakhs only) from the respondents due to injuries sustained in road traffic accident that occurred on 01.11.2024 at 6.10 p.m on Hassan – Bengaluru N.H.-75 road, near Alagondanahalli gate, Channaraypatna.

This petition coming on this 1st day of July 2026 for final disposal before Smt. Kalpana M S., BSC, LLM, PGDCLCF., 4th Addl. District and Sessions Judge, Hassan (Sit at Channarayapatna) in the presence of Sri. PK for the Petitioner and Sri. TSP- Advocate for the Respondent

It is ordered that petition filed by the claimants U/s.166 of M.V.Act is partly allowed with costs.

It is further ordered that Claimants are entitled for compensation of Rs.31,00,000/- (Thirty one lakh only) with

interest at the rate of 6% per annum from the date of petition till realization.

It is further ordered that respondent No.2 shall deposit the compensation amount with interest, within 3 months from the date of award, failing which the award amount shall carry interest at the rate of 9% per annum from the date of default.

It is further ordered that, the compensation amount awarded to claimant No.1 to 4 shall be apportioned at the ratio of 40:20:20:20 respectively.

It is further ordered that, out of the total compensation awarded to claimant No.1 and 4, 50% shall be released on proper identification and balance 50% shall be deposited in fixed deposit in any nationalized bank of their choice for a period of three years, with liberty to draw interest periodically.

It is further ordered that, the entire amount allotted to the share of claimants No.2 and 3 shall be deposited in any nationalized bank till they attains the age of majority, with liberty to the guardian to draw the interest periodically. Advocate's fee is fixed at Rs.1,000/-.
