Examination in chief by way of Affidavit of respondent:

I have filed my affidavit in lieu of examination in chief. The contents of affidavit are true and correct. I have given instructions to prepare the affidavit. It bears my signature.

ExR2: Complaint dated 02.11.2024 sent to CPI, Traffic Police Station, Channarayapatna.

ExR4: Complaint dated 02.11.2024 sent to DySP, Traffic Police Station, Channarayapatna.

Hence, I pray to dismiss the claim petition.

Cross-examination by Sri.KLC for PK Advocate for claimant :

1) I have impediment to send the complaint through post immediately after the accident for the reason of engaging in releasing the Bus and also for the reason of refusal of police to receive the complaint in the morning. There is 15 days delay in sending the complaint through post, because I was trying to file the complaint personally in the Police Station. In the Police Station my complaint was not received. I have not attempted to approach superior police officers, instead I have sent the complaint through post.

2) Police have not issued notice calling upon me to keep present in the Police Station in connection with the enquiry regarding the accident in question. I have not conducted further enquiry regarding the further action taken in respect of the complaint sent by me through post.

3) I have no knowledge about arraigning me as accused in the accident case. I have not executed indemnity bond in connection with this case. It is true to suggest that on the date

of accident I was driving KSRTC Bus bearing registration No. KA-13-F-2118. It is false to suggest that in order to avoid payment of compensation, I have made false allegation in my evidence affidavit. It is false to suggest that I have hit the KSRTC Bus to Motorbike bearing No. KA-04-EV-7622 from hind side and caused accident. I had no impediment to include the name of the eye witnesses to the accident in the complaints produced by me. I had no impediment to secure the eye witnesses / passengers to the Police Station for the purpose of statements. I have knowledge of Respondent Corporation has provided Rs.25,000/- to the family of the deceased. I have given written information pertaining to the accident to my department. I have no impediment to produce the copy of said information before this court. It is false to suggest that since the claimant has suffered injuries due to my rash and negligent driving of the KSRTC Bus. It is false to suggest that I am giving false evidence in order to avoid payment of compensation. It is false to suggest that I am liable to pay the compensation to the claimant.
