Witness does speak Hindi and the Counsel for R-2 and 3 posed questions in Hindi language and the answers are translated by them in the presence of the Counsel for petitioner.

**CROSS EXAMINATION BY SRI. KRH FOR KMS ADVOCATE FOR
RESPONDENT NO.3:**

My daughter is studying in 7th Std. The education expenses have been borne by me only. My daughter's age presently is 13 years. I have personal knowledge about the alleged accident. I do not know as to where my daughter pursuing her studies. At the time of accident, my daughter is proceeding to provision store from my house to purchase some house hold articles.

2. I know as to which vehicle caused accident to my daughter. I registered complaint on the date of incident. It is false to suggest that I registered complaint after lapse of four days with the connivance of R-1 and 2. My daughter goes to school by auto or some time by walking. We have BPL card issued by the Government. It is false to suggest that as we are having BPL card my daughter has obtained the treatment free of cost.

3. It is false to suggest that my daughter is leading her normal life and she has recovered from the accidental injury. Witness further volunteers that she still feels pain. It is true that her thumb on the left leg has broken. It is false to suggest that the driver of offending vehicle is my relative. It is false to suggest that I have not spent Rs.50,000/- towards medical expenses. It is false to suggest that the alleged accident has not occurred due to the rash and negligent driving of the driver of

the offending vehicle. It is false to suggest that as there is no fault on the part of the driver of offending vehicle, the R-3 is not liable to pay any compensation.

CROSS EXAMINATION BY SRI. MAP ADVOCATE FOR RESPONDENT NO.2:

Counsel for R-2 adopts the cross examination of Counsel for R-3.

4. I got to know the details of the driver of offending vehicle on the next date of alleged incident. I go to know about the details of driver, when I was in the hospital. Some other person had taken my daughter to the hospital for treatment. I did not attempt to gather the details of the vehicle as to which school it is belonged to. I did not know as to the which driver committed accident, but thereafter the driver of offending vehicle himself came to the hospital. When the driver came to the hospital, he told me that he has driving license to drive bus and also told about the permit details.

5. Thereafter, the driver of offending vehicle informed me that they have insured the offending vehicle.
