That you accused being a public servant, joined as Second Division Assistant at Primary Health Center, Arehalli, Belur Taluk on 9.5.1984 and then worked in the office of District Health and Family welfare, Hassan and thereafter, promoted as First Division Assistant and worked in PHC, Kundur Mata, Channarayapatna Taluk, PHC, Udayapura, Channarayapatna Taluk and thereafter, you promoted as

Superintendent and worked in the office of District Health and Family welfare, Hassan till 25.7.2013 and on 25.7.2013 on the credible information as you acquired asset more than known sources of income during the period from 9.5.1984 to 25.07.2013, Hassan Lokayuktha Police Wing was raided your movable and immovable properties standing in your name and also in the name of your family members, you were found in possession of pecuniary resources or property, to the tune of Rs.55,31,785-06 i.e. 101.04% which was disproportionate to your known sources of income and for which you could not satisfactorily account and thereby you have committed an offence punishable under Section 13(1)(e) r/w Sec.13(2) of the Prevention of Corruption Act, 1988 and within my cognizance.

And I hereby direct that you be tried by me on the aforesaid charge.
