As follows:

That on 24.07.2024, at 12.30 noon, in the land of CW.1 situated at Belagihalli Village, you Accused suspecting the illicit relationship between your wife Kempadevamma and CW.4 Manjunath while you Accused and your wife Kempadevamma were clearing weeds in the garden land, assaulted on the left cheek, strangulated her neck with a rope and committed her murder and thereby committed an

offence punishable U/s.103(1) of B.N.S., and the same is with in the cognizance of this Court.

Secondly, on the aforesaid date, time and place, you the accused after committing murder of your wife Kempadevamma, in order to screen yourselves from legal punishment, dragged body for about 60 feet into a Jowar field and thereby committed an offence punishable under Sec.238(a) of B.N.S., and same is with in the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused snatched and took away Mangalya chain, a pair of ear bangles and two finger rings of your wife and thereby committed an offence punishable under Sec.303(2) of B.N.S., and same is with in the cognizance of this Court.

And, I hereby direct that you be tried by this court on the said charge.
