**CROSS EXAMINATION BY SRI. IAM ADVOCATE FOR RESPONDENT
NO.2:**

2. I was sitting as a co-passenger in the defending vehicle. At the time of accident, I was proceeding from Bangalore to Chikkamagaluru. I had to proceed from Bittagowdanahalli circle to reach Chikkamagaluru. The alleged accident was occurred on Bittagowdanahalli circle. The said circle is spacious enough for vehicles moving. It is false to suggest that the defending vehicle collided with the offending vehicle which was coming from opposite side, while turning right side towards Chikkamagaluru. It is false to suggest that the damage caused on the right portion of the defending vehicle is due to the fault on my part. I suffered injuries on my left hand and my back portion due to the alleged accident. Soon after the accident, I was admitted to government hospital, Hassan.

3. It is false to suggest that I have not produced any single document to substantiate my in patient treatment at Government hospital, Hassan. It is false to suggest that I have not spent Rs.5,00,000/- towards my treatment.

4. The expenditure for my treatment was paid by my brother. But, I do not remember as to the mode of transaction.

5. It is false to suggest that the medical bills produced at Ex.P.5 are all created for the purpose of this case. It is false to suggest that I have created Ex.P.5 medical document in order to get more compensation from the insurance company. I have not produced any document to show that I am jobless. I was working as Account Executive in a private firm at Bangalore during the time of accident. I have not produced any document to substantiate my occupation at a private firm. It is false to suggest that I have not worked in any company at the time of accident. I have not produced any document to substantiate my earning. It is false to suggest that I was jobless during the time of accident. I am not working anywhere as on today. It is false to suggest that though I have recovered from the accidental injury and working as earlier, I am falsely deposing before this court in order to get more compensation from the insurance company.

6. It is false to suggest that I am totally recovered from the accidental injury, hence I am not entitled for any compensation from the insurance company. Witness further volunteers that I am feeling difficulty to

sit for a long time. My date of birth is 02.06.1997. I have not filed any petition seeking compensation other than this tribunal.
