Cross-examination by Sri.BCM Advocate for the respondent
NO.1:

1. My father in law is working police department. He has only one son. It is false to suggest that my father in law had on affair with another women in his advanced age and for that reason there was huge fit between my husband and his father.

2. On 09.09.2018 at about 7.30 PM my husband had gone out side to by medicine. It is true to suggest that the road leading from Govinakere to Baguru runs in the left side. It is true to suggest that R-1 proceeding from Baguru to Govinakere has to come in the right side road. The accident taken place in the left side of the road. The bike is totally damaged. It is false to suggest that on the date of accident my husband was riding the bike without headlight and himself dashed to the bike coming from the right side of the road. It is false to suggest that, due to hit by my husband to the bike of

respondent No.1, he suffered head injury and fell Unconscious. I do not know that, due to the accidental injury respondent No.1 was admitted to hospital and regain consciousness after 21 days.

3. It is true to suggest that I have not personally witnessed the accident. I came to know about the accident at 8.30 P.M. I have seen my husband at Channarayapatna Govt. Hospital. My father in law immediately knew the accident and informed me. At 9.30 PM I have reached Channarayapatna. I have not observed the presence of police at the hospital. At the time respondent No.1 was standing near the Govt. Hospital. Wife of the respondent NO.1 present therein has informed me that her husband has not received any injuries in the accident.

4. At Channarayapattana Govt. Hospital 6 stitches were put to the head injury of my husband and thereafter shifted to Hassan at Govt. Hospital. We were in the Hassan Hospital till 4 A.M. I have no knowledge of visit of police to the Hassan Hospital. Thereafter they have shifted to Mangala Hospital Hassan, and provided treatment till 4 AM of 11.09.2018.

Later on, he was shifted to JSS Hospital Mysore in an ambulance.

5.Complaint was lodged by my father in law on 11.09.2018. Since we were busy in providing treatment to my husband, we were unable to complaint immediately. It is false to suggest that , Since accident was happened due to the mistake of my husband, we have not filed the complaint immediately to the accident. It is false to suggest that, subsequently by utilizing the influence of father in law, we filed false complaint belatedly. It is false to suggest that, since the accident was occurred due to the mistake of my husband, 1st respondent is not liable to pay compensation.

6. Before filing this petition in respect of the accident of the year 2018, we have enquired with an advocate and after confirmation filed the petition. It is false to suggest that, after receipt of criminal case we came to know that claiming of this petition. It is false to suggest that, since accident was taken place due to the fault of my husband, we have not referred to claim petition immediately and after knowledge of criminal

case against respondent No.1, filed this claim petition for wrongful gain.
