Charge Sheet

State Vs. Ravi Shankar etc.

I, Deepak Yadav, JMIC, Faridabad do hereby charge you Ravi Shankar, Gaurav and Harsh as under :-

That on 05.10.2025 at about 11:30 P.M. in the area of PS Adarsh Nagar, Faridabad, you the above named accused in furtherance of your common intention voluntarily caused simple hurt to complainant Karambir with blunt weapons and thus, you thereby committed an offence punishable under Section **115(2)** read with Section **3(5) of BNS**, which is within my cognizance.
