All accused are produced before the court from Jail through video conferencing by the jail authorities. All accused are charged with the offences punishable under Section 302, 201 read with 34 of the Indian Penal Code. It is exclusively triable by the Hon'ble Sessions Court. The case needs to be committed to the Hon'ble Sessions Court for trial. The copies of police report & other documents as specified in section 207 of the Code of Criminal Procedure, 1973 have been supplied to accused by sending the copies of final report to jail authorities. All accused are in jail. The accused have orally submitted that their advocate will conduct their matter before the Hon'ble Sessions Court. Intimation about the committal of the case is given to the accused. Therefore, I pass the following order.

ORDER

1. The case be committed to the Hon'ble Sessions Court, Pune.

2. The accused are remanded to magisterial custody until committal of the case & also during and until the conclusion of trial before the Court of Sessions vide section 209 (a) and (b) of the Code of Criminal Procedure, 1973.
3. The Jail Authorities are directed to produce all accused before the Hon'ble Court of Sessions on receiving production warrant from that Court and the accused are directed to remain present before Hon'ble Court of Seesions on **12.09.2022**.
4. The record of the case, the documents and the articles if any which are to be produced in evidence, shall be sent to the Hon'ble Sessions court, Pune on or before **12.09.2022**.
5. The Police Station Officer, Police Station Bhosari is directed to produce muddemal property, if any, in the Court of Sessions on or before **12.09.2022** positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Sessions Court, Pune.
