JUDGMENT

(Delivered on 06th June, 2023)

Today, the accused are present before the Court. The accused have voluntarily pleaded guilty. They have filed such pursis also. Heard, the accused on the point of sentence. The accused submitted to impose minimum fine. Considering the nature of offence, I accept the prayer of the accused and pass the following order by taking lenient view.

ORDER

1. Accused No. 1 is hereby convicted vide Sec. 252 of Code of Criminal Procedure, 1973 for the offence punishable under Sections 68(a) of the Maharashtra Prohibition Act, 1949 and he is sentenced to pay fine of Rs. 26,000/- (Rupees Twenty Six Thousand only) in default he shall suffer simple imprisonment of 1 month, he shall surrender to his bail bonds, if any.

2. Accused Nos. 2 to 4 are hereby convicted vide Sec. 252 of Code of Criminal Procedure, 1973 for the offence punishable under Sections 84 of the Maharashtra Prohibition Act, 1949 and each accused is sentenced to pay fine of Rs. 1,500/- (Rupees One Thousand Five Hundred only), in default they shall suffer simple imprisonment of 15 day, they shall surrender to their bail bonds, if any.
