

Spl.NIA Case No. 04/2020

(RC 06/2019/NIA-GUW)

1) In this case, originally arising out *Bordumsa P.S. Case No.31/2018*, after completion of investigation by the NIA, charge-sheet dated 10.09.2020 was filed against **07 accused persons**, namely Dipankar Borah@Ghutuk **(A-2)**; Mamun Dihingia **(A-3)**; Bubul Moran@Tiger Asom **(A-4)**; BijitGogoi@ArunodoiDahotia@Arunodoi Asom **(A-6)**; Kanto Bora@Rupom Asom **(A-7)**; Santosh Gogoi@Gyan Asom **(A-8)**; and JushintoMoran@Yangkho Asom **(A-10)**.

2) Upon taking of cognizance, the instant case - *Spl. NIA Case No. 04/2020* was registered.

3) ***90 prosecution witnesses***; 64 documents, and 39 articles are listed in the charge-sheet dated 10.09.2020.

4) The prosecution is **represented** by *Sri S K Lahkar, learned Special P.P., NIA assisted by Ms M Choudhury, Ms M Das, M Bhattacharjee, N Kaushik.*

5) The accused *Dipankar Borah@Ghutuk (A-2); Mamun Dihingia (A-3)* are **represented** by learned defence

counsels *Kandarpa Baruah, N.D. Sarma, M. Alam and M Devi*; accused *Bubul Moran@Tiger Asom (A-4)* is **represented** by learned defence counsels' *K.K. Kalita, A Talukdar, K Medhi and B R Das*. The learned defence counsels representing the accused persons, who have appeared have also been indicated in a tabular format in the order dated **07.01.2021**.

6) Accused *Dipankar Borah@Ghutuk (A-2)* and *Mamun Dihingia (A-3)* are present today.

7) Consequent upon declaration of 4 accused- *Santosh Gogoi @ Gyan Asom (A-8)*, *Jushinto Moran @ Yangkho Asom(A-10)*, *BijitGogoi@ArunodoiDahotia@Arunodoi Asom(A-6)* and *Kanto Bora@Rupom(A-7)* -as **proclaimed absconders** vide order dated 09.09.2021, the case was directed to be **split up and filed with regard to them**; a supplementary record prepared and details entered in the appropriate Register.

8) With regard to the remaining accused Sri Bubul Moran **(A-4)**, pursuant to production warrant, he appears today from Central Jail, Guwahati. The production warrant is re-issued for his production / appearance on the next date.

- 9) *It may be mentioned herein that the accused Bubul Moran@Tiger Asom (A-4) had secured default bail in this case vide order dated 26.08.2019 passed by this Court and subsequently, vide order dated 09.09.2019 his bail bond was accepted and release order issued. However, he is presently in Judicial Custody in Central Jail, Kamrup(M), Guwahati in connection with Spl. NIA Case No. 3/2019 pending in this court.*
- 10) Charges have been framed against the 3 (three) accused persons vide order dated 28.09.2022.
- 11) The case is now at the **stage of prosecution evidence**.
- 12) In this regard today, no PW is present.
- 13) Issue summon upon material PWs. **Steps be taken.**
- 14) Fixed **15.09.2023** for production and **26.09.2023** for production/appearance and prosecution evidence.
