Case has been registered U/S 126(2), 115(2), 117(2), 351(2), 352, 85, 3(5) of BNS &amp; ¾ of D.P Act on 11.04.26. Accused has compromise with the informant and filed compromise petition . Hence the accuse may enlarged on bail.</p> <p>Perused the case record. On perusal of record it appears that Case has been registered U/S 126(2), 115(2), 117(2), 351(2), 352, 85, 3(5) of BNS &amp; ¾ of D.P Act on 11.04.26. The Complainant is present and supported the fact of compromise. There is no material to show that the petitioner acted in a manner so that he would be required to face "<i>custodial trial</i>". The instant case falls under the Category "A" (offences punishable with imprisonment of 7 years or less) as per the directions of the Hon'ble Apex Court in <b><u>Satender Kumar Antil v.
