**COMMITTAL ORDER**

The P.S.I., Kunigal P.S. has submitted this charge sheet against the accused Nos.1 and 2 for the offence punishable U/Sec.108 R/W/Sec.3(5) of B.N.S. 2023.

2. After filing of the charge sheet, this court took cognizance of the said offence and registered the same in Register No.III. The presence of the accused Nos.1 and 2 were secured in the open Court after they were enlarged on bail pursuant to the order passed by the Hon'ble Prl. District and Sessions Court, Tumakuru in CrI.Misc.Nos.717/2026 and CrI.Misc.No.955/2026. The accused persons were supplied with the copy of the charge sheet through their counsels as required under Section 230 of B.N.S.S – 2023.

3. I have heard both parties and perused the records.

4. The case of the prosecution is that the accused No.1 and 2 having illicit relationship since 2 years and the



said fact was known by the husband of the accused No.2. Even though husband of the accused No.2, CW-1, relatives and villagers have advised the accused No.1 and 2 not continue the same, they have not changed their attitude and continued the illicit relationship. The deceased Shivanna questioned the same, the accused No.2 abetted deceased Shivanna to commit suicide. As such on 02/05/2026, the said Shivanna killed his two sons by name Jeevan and Pranesh and he hanged himself with the help of saree to the wooden rafter and thereby the accused have committed the alleged offence punishable U/Sec.108 R/W/Sec.3(5) of B.N.S. 2023 and the offence P/U/Sec.108 of B.N.S. 2023 is exclusively triable by the Hon'ble District & Sessions Court and this court has no jurisdiction to try the said offence. Hence, this court is of the considered view that this is a fit case to be committed to the Hon'ble Prl. District & Sessions Court, Tumakuru. The accused Nos.1 and 2 are hereby directed to appear before the Hon'ble Principal District & Sessions Court, Tumakuru District, Tumakuru, as and when directed by the said Hon'ble Court.

Notify this order to District Public Prosecutor, Tumakuru District, Tumakuru.
