CHARGE

I, Smt. AISHWARYA GUDADINNI., B.A., LL.B. & LL.M., Addl. Civil Judge & J.M.F.C., Holenarasipura, do hereby charge you the above named accused persons as follows:-

That, on 20.12.2015 at around 8.00 am, at Theranya Village, falling within the jurisdiction of Holenarasipura Town Police station, you accused No.1 and 2, in furtherance of common intention have abused CW2 and CW3 in filthy language by saying "ನಿಮ್ಮ ಜಮೀನಿನಲ್ಲಿದ್ದ ಕುಂಬಳಕಾಯಿ ಬೆಳೆಯನ್ನು ತುಳಿದು ನಾಶಮಾಡಿರುತ್ತೇವೆ ಸೂಳೆ ಮಕ್ಕಳಾ ಏನು ಕಿತ್ತುಕೊಳ್ಳುತ್ತೀರಾ" knowing that it would give provocation to CW1 to breach the public peace and thereby you accused have committed an offence of intentional insult punishable U/s. 504 r/w 34 of IPC within my cognizance.

That, on the above stated date time and place, you accused No.1 and 2, in furtherance of common intention, have voluntarily restrained CW2 and CW3 from proceeding further and thereby committed an offence punishable U/sec. 341 r/w 34 of IPC within my cognizance.

That, on the above stated date time and place, you accused No.1 and 2 have threatened CW2 and CW3 show the mole with dire consequence to their life thereby committed an offence punishable U/s. 506(B) r/w 34 of IPC within my cognizance.

That, on the above stated date time and place, you accused No.1 and 2 has voluntarily fight and abettor to CW2 and 3 in filthy language, voluntarily restrained and threatened their life and thereby committed an offence punishable U/s. 114 r/w 34 of IPC within my cognizance.
