AWARD

This is an application filed U/s.166(1) of the M V Act, 1988.

The claim has been settled between the petitioner and the 2nd respondent for an amount of ₹.400000/- (Rupees Four Lakh only) and a separate joint memo has been filed. In view of the settlement an award is to be passed as follows:-
In the result:-

- a) Compensation of **₹.400000/- (Rupees Four Lakh only)** is awarded in favour of the petitioner;
- b) The 2nd respondent is directed to pay the said amount directly to the following bank account of the petitioner/s through NEFT/ RTGS or any other authorised electronic mode.

- e) The 2nd respondent shall provide Form – 16 A under the Income Tax Act, 1961 to the petitioner.
- f) The office shall make necessary entries in the registers of the Tribunal evidencing the payment of the amount to the petitioner.
